In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897), the Governor of Goa hereby amends the Recruitment Rules for the Group 'C' posts in various Departments under the Government of Goa, as follows, namely:—

In the Schedule to the Recruitment Rules for the posts of Multi Tasking Staff, Lower Division Clerk/Recovery Clerk, Junior Stenographer, Stenographer Grade-II, Junior Assistant, Senior Assistant in various Departments under the Government of Goa, in the relevant column under the heading "Educational and other qualifications required for direct recruits", under the sub-heading "Essential", wherever experience of a period of less than one year is specified or experience is not specified, the following shall be substituted/specified, as the case may be, namely:—

"Atleast one year working experience,-

- (a) as an apprentice under the Apprentices Act; or
- (b) in a Government Department/ /Organization/Office/Institute; or
- (c) in a Semi-Government Organization/ /Office/Institute; or
 - (d) in a Factory/Company; or

- (e) in any other private Establishment where not less than 05 persons are employed.
- Note:- In case of clause (e) above, the application shall be accompanied by the following documents, namely:—
 - (i) certificate of experience issued by employer.
 - (ii) certified copy of Registration Certificate of establishment issued by the Labour Inspector.
 - (iii) certified copy of the Statement in Form-I submitted by employer to the Labour Inspector.".

This notification shall come into force on the date of its publication in the Official Gazette.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Government Notification No. 1/3/2010-PER dated 22-09-2014, published in the Official Gazette, Series I No. 28 dated 09-10-2014, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Goa General Service, Group 'B', Gazetted post, in the Secretariat, Government of Goa, namely:—

- 1. Short title, application and commencement.— (1) These rules may be called the Government of Goa, Secretariat, Goa General Service, Group 'B', Gazetted post, Recruitment Rules, 2023.
- (2) They shall apply to the post specified in column (1) of the Schedule to these Rules (hereinafter called as the "said Schedule").
- (3) They shall come into force from the date of their publication in the Official Gazette.
- 2. Number, classification and level in the pay matrix.— The number of posts, classification of the said post and the level in the pay matrix thereof shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts as specified in column (2) of the said Schedule from time to time subject to exigencies of work.

- 3. Method of recruitment, age limit and other qualifications.— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification.— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission vide their letter No. COM/II/13/42(1)/07/993 dated 18-09-2023.
